#### **Opening Remarks from the Co-Chair**

Co-chair Clarke called the meeting to order at 10:03 am.

Commission is monitoring federal level happenings for potential state level impacts (i.e. Medicaid).

Welcome back to Executive Director Charmchi Goodwin.

Gretchen Shugarts, Commission Analyst, called the roll. Quorum established.

# **Meeting Minutes Approval**

Changes to meeting minutes include place of employment/organization for Patricia O'Rourke. Motion to accept December 2024 minutes made by Anthony Santella and seconded by Kevin Collins.

Voice vote to approve amended December 2024 meeting minutes. No nays. Abstentions include Douglas Brugge. Minutes approved.

### **Executive Director Report**

 Announcement in December 2024 that Mariana Monteiro will serve as the Connecticut's Chief Equity & Opportunity Officer. Position was created by Governor's July Executive Order 24-2 which was a collaborative effort following CREPH's Dismantling Structural Racism in State Government Report and championed by the Governor's Office. Save the Date – Strategic Plan preview event in late May. Will have first completed strategic
plan by July 1. The plan to be updated regularly so as to be useful to the General Assembly for
advancing equity in Connecticut. Strategic Plan preview event will be held Wednesday, May
21st.

### **2025 Legislative Session Updates**

Muna Abbas, Associate Commission Analyst

- Racial Ethnic Impact Statements (REIS)
  - Using state and national data, statements will provide an analysis of a bill and determine whether a bill is projected to either narrow or widen disparities.
  - Public Act 18-78 was passed, enabling REIS to be drafted as part of a bill but has yet to be implemented. The Commission has been assigned responsibility to conduct and implement REIS.
  - SB 1506, An Act Concerning Racial and Ethnic Impact Statements, is scheduled for a public hearing Monday, March 17<sup>th</sup>.
  - o The Commission will be hiring two analysts to conduct REIS a principal and junior analyst.
- Dr. Santella asked about expectations regarding volume of work for two new analysts. Abbas
  explained that REIS will not be conducted for all bills but there will be an agreed upon process
  between the Commission and legislators for conducting REIS.

# Gretchen Shugarts, Commission Analyst

- Insurance-based Testimonies
  - SB 1192, An Act Concerning Hospital Financial Assistance, seeks to address medical debt.
     Testimony already submitted. Supported concept of the bill and made recommendations to strengthen the bill.
  - SB 10, An Act Concerning Health Insurance and Patient Protection. Currently drafting testimony which will focus on stop loss policies and the risk segmentation that occurs in the fully-insured market as a result.
  - HB 7039, An Act Concerning Health Insurance. Will submit testimony. Bill seeks to put limits on retroactive denials of insurance claims (aka clawbacks).
  - HB 6589, An Act Concerning Maternal Health. Will likely submit testimony supporting the establishment of a report card for birth centers and hospitals

# **UConn Health Disparities Institute (HDI) Presentation**

Valen Diaz, Projects Director, and Gillian Betz, Research Associate

- Community-Based Participatory Research and Strategic Planning Process Project Update
  - Based on conversations with subcommittee members, HDI drafted priorities and solutions that were responsive to Phase 1 findings
  - Subcommittee members finalized priority areas for Strategic Plan
  - o Community Research Team prioritized solutions for Phase 2 assessment
  - Phase 2 assessment will consist of surveys and virtual focus groups/interviews with key informants (currently in progress)
  - o Timeline
    - March 2025: Collect and analyze data
    - April 2025: Present findings and revised solutions; determine solutions in final subcommittee meeting with all subcommittees
    - May 2025: Finalize solutions; preview strategic plan
    - June 2025: Finalize and release strategic plan; plan for dissemination
  - Phase 1 assessment reports available on Commission website and shared back with all respondents/participants

### Doug Brugge, UConn Health

- Since the survey was translated into 9 languages, Brugge asked about outreach for obtaining meaningful sample. Per Valen:
  - The Community Research Team has been generating a far-reaching list of contacts to share the survey with
  - Have asked all subcommittee members to assist with distribution

### Anthony Santella, Fairfield University

- Question regarding data collection. What's the goal for obtaining a representative sample and can timeline be adjusted?
  - Valen stated there will be limitations.
    - Timeline has very limited flexibility.
    - Stressed transparency regarding limitations of the assessment.

# Faryal Mirza, UConn Health

Has survey been distributed via UConn's broadcast email within UConn Health system?
 Valen stated they have not yet shared with the UConn Health Lifeline but is something they could do.

### Doug Brugge, UConn Health

Appreciated Santella's point about sample. The goal is not a representative sample. Brugge
wonders about framing: The outreach aim is a targeted effort to get responses from those that
are mostly adversely affected by disparities in state. Helps to justify the sampling strategy since
that is the population that is most important to survey.
