Collaborate **Domestic Violence**

Promote the passage of a Domestic Violence Survivors Justice Act (DVSJA) in CT as was passed in NY, which codifies meaningful sentencing reductions for Domestic Violence abuse survivors in the criminal system.



The Domestic Violence Survivors Justice Act would give judges the flexibility to sentence domestic violence survivors convicted of offenses related to their abuse to shorter sentences or to alternative-toincarceration programs, and would give those sentenced prior to the law's enactment the chance to apply for re-sentencing.

By untying judges' hands and giving them discretion, the DVSJA would help restore humanity and justice to the way we treat survivors of severe abuse who act to protect themselves and would bring long overdue relief to survivors who have been incarcerated for many years.

Collaborate Fair Work Schedules

Promoting fair and flexible work schedules would require employers to provide notice to employees about their work schedules. The employer's responsibility is to provide notice to the employees of the regular and on-call hours, including start and end times for each shift, and work schedule changes. This would allow employers and employees to be on the same page and allow the possibility to resolve any work schedule conflicts early on.



Collaborate Female Genital Mutilation/Cutting

A Connecticut ban on FGM/C is time-critical, as other New England states have passed laws criminalizing FGM/C, and Connecticut is also the only state bordering New York in which FGM/C is legal (an estimated 48,418 girls and women are currently at risk for FGM/C in New York). We do not want our state to be a destination for FGM/C.
