Meeting was called to order at 10:00 AM on Thursday, November 12, 2020.

WELCOME AND INTRODUCTIONS

Co-Chairperson Jarmoc and Co-Chairperson Tan welcomed everyone and thanked them for attending this meeting via zoom

PRESENTATIONS FROM GUEST

Both Ms. Zorn and Ms. Miller presented on Public Options Campaign, the campaign is to see how they can get more people in Connecticut to have healthcare.

There is a health care crisis: Cost

- Affordability challenges for individuals
 - o Premiums
 - Deductibles
 - Co-pays, co-insurance
- High deductible health plans



- Rising prescription drug prices
- Hospitals
 - Consolidation
 - Rising prices

A survey in the middle of COVID was conducted because they wanted to know how people were feeling with this crisis of cost.

- 51% experienced a problem affording health care in the past year
- 24% had difficulty paying medical bills
- 24% delayed or avoided going to the doctor to get care because of worries about cost
- 19% reported either cutting pills in half, skipping doses, or not filling a prescription at all.

Another mayor issue is the continuing and really widening gap in how different people in our state experience health and health care (Racial and Ethnic Disparities).

- People of color
 - More likely to be uninsured
 - More likely to die early or suffer from preventable illness
 - Live with higher rates of chronic stress, chronic disease, maternal mortality, and low infant birth weight
 - Undocumented immigrants have the highest uninsured rate in Connecticut

Health Care Crisis: COVID 19

- Historic levels of unemployment
- Small businesses closing
- 30% increase in number of uninsured
- Higher rates of cases and deaths among Black and Latinx people
- 54% worried about affording COVID-19 treatment
- Underinvestment in public health infrastructure
- Underinvestment in combatting the social determinants of health

Since 2019 a group of advocates and legislators along with the Comptrollers office have been working together to try to see how they could address these problems. The Mission is to build on successful government programs and practices to ensure every person in Connecticut has equitable access to affordable, quality health care. The vision is that all people in Connecticut have equitable access to affordable, quality healthcare.

The goals are:



- to improve affordability and quality of health insurance options in the employer-based and individual markets
- Advance health equity by increasing access to health coverage and care
- Increase the rate of insured people in Connecticut
- Increase the number of people who can access quality care because it is affordable to them.

This crisis demands urgent action that meets the moments. Quality health care in Connecticut must be affordable and available to everyone. We must ease the financial burden on working families by lowering health care costs. Grow the economy by labeling the playing field for small businesses and nonprofits. Address racial inequities by expanding access to quality, affordable health care. Provide new health care options by leveraging the market power of the state health plan. Build on the success of the Affordable Care Act (ACA) and defend its protections. Improve public health and guard against future crises by providing health care people can us.

Ms. Courpas presented on their current initiative which they were thrilled to share with us, as part of their COVID response, they have created a statewide data collection initiative to really assess the economic impact of COVID-19 on Connecticut's women.

- Hard data survey: Impact by the numbers
 - o 30 question written survey takes 5 minutes to complete in English and Spanish
 - Disseminated broadly through women's' service, professional, legislative, nonprofit, business, and other channels
 - o Goal is to reach large and wide cross-section of Connecticut's women
- 8 Zoom forums in each CT county: Tell Your Story
 - Input directly from CT's women on COVID-19s impact on their economic security
 - Public Zoom Forums from 7pm 8pm
 - Mon., Nov. 16th: Tolland and Windham Counties
 - Tues., Nov. 17th: New London County
 - Wed., Nov. 18th: New Haven and Middlesex Counties
 - Wed., Dec. 2nd: Hartford and Litchfield Counties
 - Thurs., Dec. 3rd: Fairfield County
- Final report: First quarter of 2021

They are pushing to have a broad and diverse group of women taking the survey, by race, age, location, state socioeconomic and educational level. There are many ways to take the survey; website access, printable, QR code, available in English and Spanish.
